The standards for these innovations to fishing practices are that performance is scientifically demonstrable and economically viable for the fishing industry. Examples over the last 25 years include trawl modifications to reduce halibut bycatch, development and implementation of careful handling procedures to reduce bycatch mortality, redesign of flatfish trawls to reduce seafloor impacts, and modifications to pollock trawls to allow Chinook salmon escapement. The above listed work has been done through



research collaborations between the fishing industry and NMFS/university scientists in partnerships structured around knowledge/skill sharing and mutual respect and trust. Email: gauvin@seanet.com
